## Wind Turbines

- 3391. SHRI K. PRADHANI: Will the Minister of ENEGRY be pleased to state:
- (a) whether some Dutch Wind Turbines manufactures have formed a syndicate to introduce wind turbines in the Indian market;
- (b) if so, whether any Indian films have come to his Ministry seeking approval to enter into partnership with this Syndicate; if so, the details thereof; and
- (c) whether any trials about the use of wind turbines, has been made in India; if so its utility?

THE MINISTER OF ENERGY (SHRI P. SHIV SHANKAR): (a) No information about such a syndicate has reached the Government so far.

Audience Research Units attached to various Doordarshan Kendras conduct. from time to time, surveys to assess the of audience to various programmes. The findings of these surveys as well as suggestions received otherwise are kept in view while introducing suitable changes in the programme fare. Improvement of programmes is, however, a continuous process. Government has, appointed a Working Group of distinguished persons/communicators to suitable recommendations on software planning of Doordarshan. On receipt, the report of the Working Group will be considered for further necessary action.
