Applications for Industrial Power load in Delhi

- 187. Shri Balraj Madhok: Will the Minister of Irrigation and Power be pleased to refer to the reply given to Unstarred Question No. 3616 on the 6th September, 1961 regarding registration of applications for Industrial Power load for Small Scale Industries in Delhi and state:
- (a) whether Government received representation to the effect that applications pertaining to the year 1957-58 are actually pending with the Delhi Administration to whom industrial power load has not been sanctioned so far:
- (b) whether Government made enquiries and if so, with what results;
- (c) if the reply to part (a) above is in affirmative, will Government now state the reasons thereof; and
- (d) whether Government will state when the industrial power load would be supplied to those applicants?

The Deputy Minister of Irrigation and Power (Shri Hathi): (a) One representation was received by the Delhi Administration.

- (b) and (c). Enquiries made in the matter reveal that the original application referred to in the representation which was addressed to the Delhi State Electricity Board had not been forwarded to the Delhi Administration.
- (d) The name of the applicant has since been included by the Delhi Administration in the approved list, for enhancement of his power load from 2½ HP to 5 HP. The load will be sanctioned as soon as power supply position in Delhi improves.

Money Order Service in Orissa Post Offices

- 188, Dr. Samantsinhar: Will the Minister of Transport and Communications be pleased to state:
- (a) whether it is a fact that no money orders sent by the Education Department to Primary School Teachers are accepted during the first week of a month and in subsequent weeks not more than fifty in a day are accepted by the concerned Post Offices in Orissa:
 - (b) if so, the reasons therefor; and
- (c) whether Government propose to change the procedure in view of the hardship of the teachers?

The Minister of Transport and Communications (Dr. P. Subbarayan): (a) and (b). Usually during the first week of the month, there is a rush at the money order booking counter and queues are formed. A large number of money orders also booked by the Education Deptt. addressed to Primary School teachers. If these are taken up for booking in the first week of the month, others intending to book money orders are likely to be inconvenienced. The Education Department of Orissa and the local postal authorities, therefore, mutually agreed to book the money orders from Primary School teachers after the first week of the month in batches of 50 per day at the Puri Head Post Office.

(c) Yes, Sir. Alternative arrangements are under consideration.
