that 37,000 pensioners have been paid a total sum of Rs. 69,37,000 on account of arrears. Large numbers of further payments would have been made since then.

A sizeable addition to the office of the Controller of Defence Accounts (Pensions) Allahabad has been sanctioned for a period of two years with effect from the 1st February 1961, in this connection. As regards Post Offices, a commission is paid on the amounts of pension actually paid to military pensioners, and the question of providing extra staff in the Post Offices falls within the purview of the General. Post and Director Telegraphs. Payment through Post Offices is made in the Delhi and Punjab Circles. Necessary instructions are being issued by the Post and Telegraph Directorate for the provision of Certain extra staff, as well as utilisation of available manpower for clearing the accumulations in the matter of payments to the pensioners.

## Shifting of Courts from Tirumal Naik Palace
