Beas Dam Project

27. **Shri P. C. Borooah:** Will the Minister of Irrigation and Power be pleased to state:

(a) the number of villages which are to be evacuated and their land acquired for the implementation of the Beas Dam project District-wise;

(b) at what place the inhabitants of these villages are proposed to be resettled;

(c) whether they are proposed to be shifted to some place outside the State to which they belong; and

(d) whether evacuation notices have been issued to the inhabitants of these villages?

The Deputy Minister of Irrigation and Power (Shri Hathi): (a) Land and abadis of 52 villages in Kangra District will be submerged on the creation of the reservoir.

The land of 9 villages in Hoshiarpur and two villages in Kangra District has been acquired for a Township and construction facilities but the village abadis will not be acquired.

(b) and (c). The oustees of the Beas Dam areas are proposed to be resettled on the land in the Rajasthan Canal Zone in Rajasthan, as the land is not available within the Punjab State.

(d) So far no evacuation notices have been issued to the inhabitants of these villages.
