(b) In the Sixth Plan, it is envisaged to increase the number of veterinary hospitals from 4254 to 4930 and veterinary dispensaries from 7973 to 9270 in the country as a whole. Generally

State-wise and not Block-wise targets are fixed. Veterinary dispensaries and hospitals are established keeping in view the requirements of the area and the availability of financial resources. The number of veterinary dispensaries/hospitals at the beginning of the Sixth Plan

(1979-80) and the target at the end of the Sixth Plan (1984-85) alongwith the cattle population (1977 census) State-wise, as given in the Statement is in indicative of the coverage.
