Coup-D'etat in Burma

507. **Shri Bibhuti Mishra:** Will the Prime Minister be pleased to state:

(a) whether it is a fact that a *coup-d'etat* took place in Burma on the 2nd March, 1962;

(b) if so, whether Government of India received any message from Burma about the safety of the Indians there and their property; and

(c) whether the change of Government there will affect in any way India's trade ties with Burma?

The Prime Minister and Minister of External Affairs (Shri Jawaharlal Nehru): (a) Yes Sir.

(b) No loss of life or property of Indians in Burma has been reported.

(c) It is not expected that trade between India and Burma will be affected by other than normal consideration, as heretofore.
