(a) whether enquiry conducted by Government into the affairs of the Smith Stanistreet and Pharmaceuticals Limited, Calcutta on the complaints by the Workers Union had been completed;

(b) if so, the details of the investigations; and

(c) the action taken against the officers concerned for indulging in malpractices ?

VASANT SATHE) : (a) to (c) The Management of Smith Stanistreet and Pharmaceuticals Limited have reported that enquiry on all charges was completed and that prima-facie irregularities were observed in purchase of boiler only. The Company initiated departmental enquiry against three officers.

THE MINISTER OF STATE IN THE MINISTRY OF COMMUNICATIONS (SHRI V.N. GADGIL) : (a) Yes, Sir.

(b) Complaints received during 1.1.82 to 31.12.83 are :—

(c) Following is the action taken by Government to solve the problem and to improve the telecommunication system :—

At Bhavnagar :

- (i) Complaints regarding non-working of telephones/trunk circuits were attended to immediately and faults rectified.
- (ii) Staff complaints were thoroughly investigated and complaints were replied suitably.
- (iii) Periodical meetings with Chamber of Commerce by Divisional Engineer Telegraphs and Sub-Divisional Officers Telegraphs were being held to discuss the problems and redress the grievance of the subscribers. Prompt action is being taken to improve the telecommunication service.

At Amerli :

- (i) Complaints against non-working of telephones were attended to immediately and faults rectified.
- (ii) Complaints regarding excess billing were settled.
- (iii) Maintenance routines and inspections are being tightened up.
