(a) the names of the States from which chrome ore is being procured for export purposes;

(b) the quantum of chrome ore being procured annually from Orissa for export;

(c) whether there was a demand for the abolition of export duty from chrome ore; and

(d) if so, the steps taken by the Government thereon ?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND IN THE DEPARTMENT OF SUPPLY (SHRI NIHAR RANJAN LASKAR): (a) Chrome ore is being procured from the States of Orissa and Karnataka for export purposes.

(b) More than seventy per cent of the quantity of Chrome ore exported annually is procured from Orissa.

(c) and (d) Yes, Sir. The export duty on Chromite was reduced from  $10^{\circ}/_{\circ}$  advalorem to  $5^{\circ}/_{\circ}$  ad-valorem w e f. 15th February, 1983.

## Credit to Unemployed Youth Under Self-Employment in Orissa

9956. SHRI HARIHAR SOREN : Will the Minister of FINANCE be pleased to state the details of the loans given by various commercial banks in Keonjhar district, Orissa under self-employment scheme ?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI JANAR-DHANA POOJARY, : As per information received from the Ministry of Industry upto 31st March, 1984, 218 cases amounting to Rs. 39.48 lacs were sanctioned by the banks under the scheme of Self-Employment of Educated Unemployed Youth. Of these, loans amounting to Rs. 9.00 lacs were disbursed to 129 beneficiaries by that date.
