- (b) if so, facts thereof;
- (c) how do Government propose to meet this threat posed to the country's security;
- (d) the steps proposed to be taken to haul up the dastardly gangs of poachers mainly from Taiwan, who are plying havoc with the Indian Fishing Industry off the West Coast?

THE MINISTER OF DEFENCE (SHRI R. VENKATARAMAN): (a) Yes, Sir.

- (b) There have been poaching activities of the foreign fishing trawlers, but no espionage case linked with poaching activities have come to light so far.
- (c) and (d) Constant surveillance is maintained by Coast Guard Ships and aircraft particularly in the sensitive areas of our maritime zones. Indian Navy also in the course of its routine deployment, maintains surveillance and is empowered to apprehend violators. Government is, however aware about illegal fishing by foreign fishing vessels in our Territorial Waters. Some of these vessels have been apprehended and prosecuted in the past. With the acquisition of more ships and aircrafts which has been provided for in the Coast Guard Development Plan, the Coast Guard will be able to carry out more effective surveillance of the area.

Import of Heavy Industrial Machinery from Soviet Union

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND IN THE DEPARTMENT OF SUPPLY (SHRI NIHAR RANJAN LASKAR): (a) 10 (d) Keeping in view the balanced bilateral rupee trading arrangements with the Soviet Union and need for diversification of the items of imports, adequate provisions are made from time to time for import of various machinery and other items in the Trade Plans with the USSR. Individual purchase decisions are, however, taken by competent purchasing authorities. view the various relevant keeping in aspects like specifications, prices, delivery period etc. Since enhanced imports of machinery and equipment from the USSR help in the generation of rupee resources and consequently in promoting exports from India, the indigenous machine building industry stands to get benefitted to that
