Plans for Building Houses on the Vacant Plots

10079. SHRI RAM VILAS PASWAN: Will the Minister of WORKS AND HOUSING be pleased to state :

- (a) whether it is a fact that the plans for building houses on the vacant plots declared 'residential' in regularised colonies in the Capital are not yet passed by the authorities concerned like DDA, NDMC etc.:
- (b) if so, the reasons therefor and the likely time by which Government propose to approve such plans in the regularised colonies particularly, Navrang colony, in the Western Zone; and
 - (c) if not, the reasons therefor?

THE DEPUTY MINISTER IN THE DEPARTMENT OF SPORTS IN THE MINISTRY OF WOKS AND HOUSING AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN) (a) to (c) The building activity is allowed by the MCD on payment of development charges in the 103 colonies which were regularised by its Standing Committee during the years 1960-62 including the plots adjusted therein as per the revised regularisation plans of these colonies approved subsequently. The building plans of vacant built up plots in the other recently regularised unauthorised colonies including Navrang colony situated in Tri Nagar Group of colonies are not being sanctioned by the DDA and MCD at present pending settlement of issues like instalment and mode of recovery of development charges from the beneficiaries and the policy for approval of building plans in these colonies.

Future Trading in Cotton

D.S.A. 10080. SHRI SIVAPRA-KASAM: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:

- (a) whether it is a fact that future trading in cotton has been stopped;
- (b) if so, the reasons for such stoppage; and
