is laying another path for use by people by dismantling a part of the park;

- (b) if so, the reasons that NDMC has failed to get the encroachment cleared;
- (c) whether the Babu Market in Sarojini Nagar, New Delhi is also heavily encroached around both sides of the service roads and near the vegetable market;
- (d) if so, is there any proposal to get the encroachments cleared forthwith and
  - (e) if not, reasons thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF WORKS AND HOUS-ING (SHRI MOHAMMED USMAN ARIF): (a) The NDMC has reported that the verandhas have been encroached upon and that a footpath is being laid on the open passage which existed in the market around the NDMC park.

- (b) The matter is sub-judice, as reported by the NDMC.
- (c) to (e) Reports in this regard have been received and necessary action has been initiated.

## Funds Released for A.I.C.R.P. at Hissar

10156. SHRI B.D. SINGH: Will the Minister of AGRICULTURE be pleased to refer to the reply given to Unstrared Question 7118 on April 9, 1984, regarding funds released for AICRP at Hissar and state:

- (a) the genetic-group-wise, year-wise, number of cows millked and correspondingly annual quantity of milk produced from 1977-78 to 1983-84 and its sale price year-wise, from start of Hissar centre upto 1 April, 1984;
- (b) the sanctioned total annual amount payable by Indian Council of Agricultural Research vis-a-vis that released from 1973-74 upto 1983-84

correspondingly and separetely in each year for non-recurring components only, the sanctioned amount associated with enhanced releases:

- (c) what performance/traits and norms against which each being compared Review Committee/Workshops used to productivity decreased; and
- (d) how long Government propose to continue Indian Council of Agricultural Research support to Hissar centre?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE: (SHRI YOGENDRA MAKWANA): (a) The number of cows in milk genetic-group-wise and year-wise from 1977-78 1983-84 are given in statement-I. Correspondingly genetic-group-wise, year-wise, milk produced upto 1982-83 to is given in statement II. The figures in respect of milk produced for 1983-84 and sale price of milk year-wise is being collected and will be placed on the Table of the House in due course.

- (b) The sanactioned total annual amount payable by the Indian Council of Agricultural Research and released by the Council and the corresponding sanctioned amount for non-recurring items is given in statement-III.
- (c) The Mid-Term Review Committee used the following criteria for judging the performance of the Unit:—
  - Generation of corss-bred animals in various genetic groups, the examination of reasons for shortfall, if any.
  - (2) (2) Recording of performance.
  - Attainment of targeted production.
  - (4) Mortality and diseases incidence.

The Mid-term Appraisal Committee had found the overall performance of the Unit to be satisfactory, although it had problems in acquiring the requisite number of foundation female stock and though there was delay in generation of requisite number of animals in different genetic groups. Production levels in different years would not be comparable in

the light of the genetic group composition.

(d) The project currently is sanctioned upto the end of the Sixth Plan period.
