(क) क्या यह सच है कि उन्हें अखिल भारतीय स्वतंत्रता सेनानी संगठन और दिल्ली के स्वतंत्रता सेनानियों की ओर से दिल्ली में स्वतंत्रता सेनानी कालोनी के निर्माण का निवेदन किया गया है;

(ख) यदि हां, तो तत्सम्बन्धी व्यौरा क्या है; और

(ग) उसके प्रति सरकार की क्या प्रतिक्रिया है ?

#### Allotment of Land/Flats to M.Ps

SHRI TRILOK CHAND :

Will the Minister of WORKS AND HOUSING be pleased to state :

(a) whether it is a fact that Government allot land or flats to the Members of Parliament;

(b) if so, that details of the rules in this regard;

(c) the number of Members of Parliament who have applied for land, flats or other houses in Delhi during the last three years;

(d) the number of Members of Parliament who have been allotted land flats during this period; and

(e) the basis therefor ?

THE DEPUTY MINISTER IN THE DEPARTMENT OF SPORTS OF THE MINISTRY OF WORKS AND HOUSING AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN) :

(a) and (b) 3% of flats are reserved by DDA for Members of Parliament registered under Self Financing Registration Scheme IV & V. There is no reservation of plots for M.Ps.

(c) Nip, as no fresh applications of special quota for allotment of plots/flats for MPs (and certain other categories) with effect from 2.1.79, it was decided to consider the pending applications as on 2.1.79 for allotment of plots by fixing a suitable prospective date for completion of formalities connected with the allotment. The allotment has been made by DDA in 33 cases vide statement 'C' in the draws held on 4-8-82 and 12-12-83.

Flats : The particulars of Members of Parliament who have been allotted flats under Self Financing Scheme and General Housing Scheme are given in statement 'A' and statement 'B' respectively. Since the special quota for allotment of flats was also abolished w.e.f. 2-1-79, the pending applications were treated on the analogy of those who applied for allotment of the plots as explained above.
