Allottment of Land to SD Education Society Karol Bagh

10255. PROF. NARAIN CHAND PARASHAR: Will the Minister of WORKS AND HOUSING be pleased to state :

- (a) whether the Land Development Office in or around 1966 had allotted plot to S.D. Education Society, Delhi to run the Government aided JVSD Girls Senior Secondary School at D-II Jhandewalan Extn., Karol Bagh, New Delhi:
- (b) if so, whether possession of the Society has been given and if so, the date thereof;
- (c) if not what steps his ministry or its agencies like DDA have taken to hand ever possession to the S.D. Education Society; and
- (d) the date by when thay be able to do so and the reasons for delay?

THE DEPUTY MINISTER IN THE DEPARTMENT OF SPORTS, IN THE MINISTRY OF WORKS AND HOUS-ING AND IN THE DEPARTMENT OF PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN): (a) A plot of land measuring 1.4 acres which was earlier placed with the DDA for care and maintenance had been allotted and the physical possession handed over to the Society on 3 6.1966. However, three . squatters obtained stay orders from the Court against the Delhi Development Authority. The Land & Development Office had requested the DDA to get the stay order vocated early.
