(d) if so, whether Government will re-examine the move and take it up with F.C.I. for cancellation of the same?

THE DEPUTY MINISTER IN THE DEPARTMENT OF ELECTRONICS AND IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (DR. M. S. SANJEEVI RAO): (a) and (b) No decision has been taken to shift Rice Mills of food Corporation of India from West Bengal and Orissa to other States.

(c) The original proposal to construct a 50,000 M. T. port silo at Haldia was dropped on operational and economic considerations.

(d) There is at present no proposal to reconsider the matter.

Suggestions to Plug Loopholes in the Implementation of I. R. D. P.

2514. SHRI K. MALLANNA: Will the Minister of RURAL DEVELOP-MENT be pleased to state :

(a) whether it is a fact that his Ministry has suggested a change in the format of the Integrated Rural Development Programme to plug loopholes in the use of subsidy given for the programme; and

THE MINISTER OF STATE OF THE MINISTRY OF RURAL DEVELOP-MENT (SHRI HARI NATHA MISRA): (a) and (b) Some procedural changes to minimise misuse of subsidy are being explored. One of the suggestion which is examined in this Ministry is the possibility of adopting the system of assistance announced for the educated unemployed in which the subsidy is kept in deposit with the Bank with interest accruing to the beneficiaries and is adjusted against the instalments of recoveries when they fall due.
