Disturbing Trend in Shipping Industry

- SANAT KUMAR 3142. SHRI MANDAL: Will the Minister of TRANSPORT SHIPPING AND pleased to state:
- (a) whether disturbing trends shipping industry have been noticed in

the recent years and the number of vessels has registered a decline;

- (b) if so, the reasons therefor;
- (c) how far it has come as a boon to the foreign shipping lines particularly those in ulging in tramp shipping; and
- (d) what plan, if any, has been formulated for development of containerisation to keep pace with the world shipping?

THE MINISTER OF STATE IN THE MINISTRY OF SHIPPING AND TRANSPORT (SHRI Z.R. ANSARI) : (a) and (b). The Indian Shipping Companies are facing financial problems due to the world-wide recession shipping. As a result, the pace acquisition of new vessels has slowed down. This has led to a marginal decline in the number of ships in Indian registry though in gross tonnes there has been a marginal increase. The number of vessels registered along with the total GRT on 31st December of the last three years is given below:-

- (c) The change is too marginal to tilt the balance in favour of foreign shipping lines.
- (d) Indian Shipping Lines especially Shipping Corporation of India have decided to go into the full container concept and accordingly acquisition of cellular ships is under process. Inland Container depots have process. Inland Container depots have been set up on a Project basis by the Railways at Bangalore Guntur/Anaparti, Coimbatore and New Delhi. It has been decided to set up full-fledged Inland Container Depots at Bangalore, Gauhati and Delhi.

Container handling facilities have been geared up at the Ports of Bombay, Cochin, Madras and Haldia/Calcutta. A full-fledged container terminal has been commissioned at Madras. berths have been earmarked at Bombay and Haldia for container traffic.

A Working Group with representatives of the Ministries of Railways, Shipping and Transport, Commerce. Planning Commission has been set up to formulate the requirements of facilities for container traffic in the Seventh Five-Year Plan.

According to the modified procedures admissions from 1984-85 to Jawaharlal Nehru University would be on merit subject to normal reservations. merit will be determined through a uniform all India examination to be held at 21 centres throughout the country. There will be no interview for Master's degree programme.

modified procedures were evolved after extensive consultations

within the University community including students. However, a section of students have been opposing the modifications in the admission procedures. Their main demand is that provision for weightage for economic, social regional deprivations should be restored.

(d) The Jawaharlal Nehru University made reservations to extent of 15% for Scheduled Castes, 7½% for Scheduled Tribes and 3% for physically handicapped. The total number of Scheduled Castes Scheduled Tribes students in Jawaharlal Nehru University at present, course wise, is as follows:
