THE MINISTER OF CHEMICALS AND FERTILIZERS (SHRI VASANT SATHE): (a) The prices of price controlled bulk drugs specified in the Drugs (Prices Control) Order, 1979 are regulated under the said Order. The control on prices ensures that they become available to the consumers at fair and reasonable prices. The regulation of prices included changes in prices depending upon changes in costs from time to time.

- (b) Yes, Sir.
- (c) There is no proposal to have two-tier price formula in respect of Drugs.

Workers Participation in Management in Public Industries in Orissa

THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND REHABI-LITATION (SHRI DHARMAVIR): (a) to (c). Government have recently introduced a new comprehensive scheme for Workers' Participation in Management vide Government's Resolution dated 30th Decem-

ber, 1983 (Published in Part I, Section 1 of the Gazette of India (Extra-ordinary) dated 30th December, 1983). The Scheme is applicable to all Central Public Sector Undertakings. The Scheme is comprehensive and contains provisions on various aspects like representation, functions at different levels and monitoring etc. The State Governments (including Orissa) have been requested on 9-1-1984 to introduce the Scheme in their public sector undertakings.

(b) Expansion of TV in the country is being carried out in a phased manner. A Low Power Transmitter is being set up in Karim Nagar which will provide service within a range of about 25 Kms.
