nery besides augmenting the existing analysis facility of the agricultural inputs so that more number of samples are drawn and analysed. They have also been advised to undertake more frequent inspection of dealers/distributors as well as to draw and analyse more samples.

Written Answers

(d) The existing provisions of the Essential Commodities Act, the Fertiliser Control Order, and the Insecticides Act along with rules framed thereunder are considered to be adequate for action against the unserupulous manufacturers and adulterators of pesticides and fertilisers.

Revival of Measures having Effect on Rise in Prices

- 270. SHRI MADHAVRAO SCINDIA: Will the Minister of FOOD AND CIVIL SUPPLIES be pleased to state:
- (a) whether Government have of late considered reviving some of the measures which had evident and salutory effect of containing the prices such as the price list display, price tags system and the broadcasting and telecasting of retail prices, enforced during 1975-77, which had been withdrawn in 1977; and
- (b) if not, the reasons for the same especially in view of the ever-rising trend of prices ?

THE DEPUTY MINISTER IN THE DEPARTMENT OF ELECTRONICS AND IN THE MINISTRY OF FOOD AND CIVIL SUPPLIES (DR. SANJEEVI RAO): (a) and (b). The question of reviving the scheme for displaying prices of essential commodities does not arise as all the State Governments/U.Ts. have already issued price/stock display orders under the Essential Commodities Act, 1955 and are duly enforcing them. Price display is also mandatory on packaged commodities under the Standards of Weights and Measures (Packaged Commodities) Rules, 1977. In-sofar as All India Radio is concerned wholesale prices of agricultural products are announced in the Farm and Home Programmes meant for farmers and other rural listeners. Besides, the prices of essential commodities prevailing in Super Bazar are broadcast daily from the Delhi Station of the All India Rad.o. Doordarshan Kendra, Delhi, is telecasting the rates of essential commodities regularly on Tuesdays and Fridays.
