

ensure availability of standard quality of fertilisers to the farmers. They have been requested in this context to strengthen and gearup their enforcement machinery and to augment the analysis facilities for testing more and more fertiliser samples. In addition, Central squads have been sent from time to time to various places for surprise checks. Samples drawn by them have been analysed at Central Fertiliser Quality Control and Training Institute, and results communicated to State Governments concerned for taking necessary action wherever needed. The Central Government have recently approved the creation of three regional laboratories in addition to the existing Central Fertiliser Quality Control and Training Institute at Faridabad, for the purpose of strengthening the facilities of training, enforcement and monitoring of the quality control of fertilisers.

(b) if so, whether it is a fact that response from the buyers was not satisfactory and that last date for the receipt of applications was extended two times ;

(c) if so, the details and reasons for the lack of response ; and

(d) what corrective measures are being taken for the early disposal of flats ?

THE DEPUTY MINISTER IN THE DEPARTMENT OF SPORTS, IN THE MINISTRY OF WORKS AND HOUSING AND IN THE DEPARTMENT OF

PARLIAMENTARY AFFAIRS (SHRI MALLIKARJUN, : (a) Yes. The DDA propose to sell 599 dwelling units in Asiad Village Complex, Siri Fort, New Delhi to the following categories of persons against payment in Foreign Exchange :

(i) Indian nationals residing abroad ;

(ii) Indian nationals serving in International Organisations either in India or abroad who can legitimately pay in foreign exchange ;

(iii) Indian nationals who were International employees until recently but have returned to India and would be able to pay in foreign exchange within the permitted period of maintenance of a foreign account.

(b) to (d). The last date for receipt of applications having been extended upto 29.2.84, it would be premature to make any meaningful assessment of the response. The position will be reviewed on the expiry of the last date for receipt of applications.
