So far, replies have been received from four of them,

(c) One of the terms of reference of the Law Commission is to revise the Central Acts of general importance so as to simplify them and to remove anomalies, ambiguities and inequities. The Commission has taken up a study of the subject up moto in view of its general importance The question as to how the interests of the consumers will be safeguarded by amending the law can be considered only after the Commission has completed its study and submitted its recommendations to Government.

Settlement of Grievances of Ex-servicemen in A,I R.

588: SHRI MANOHAR LAL SAINI; Will the Minister of INFORMATION AND BROADCASTING be pleased to state :
