THE MINISTER OF CHEMICALS AND FERTILIZERS (SHAL VASANT SATHE): (a) and (b) The National Drugs & Pharmaceutical Development Council (NDC) in its first meeting held on 28.5.1983 decided to constitute three Working Groups viz:

- (1) Working Group on Industrial Approval.
- (2) Working Group on Pricing Policy and Procedures.
- (3) Working Group on Planning and Development.

The Working Group recommendations will be considered by the NDC. The recommendations of the NDC would them be placed before the Consultative Committee of the Ministry. Finally the decisions of the Government would be placed on the Table of the House.

(c) In addition to the three Working Groups of the NDC referred to above. two other Inter-Ministerial Groups-one to go into the question of validity of the production of drugs under Industries (Development & Regulations) Act, 1951 and the other to go into the question of production and marketing of Protien Hydrolysate and Protinex by M/s. Pfizer Limited were constituted on 13th August, 1982 and 17th September, 1983 respectively. The Groups are expected to submit their reports shortly
