#### Bank Loans vis-a-vis profits of Banks under Self-Employment Scheme

1830 : SHRI R. P. DAS : Will the Minister of FINANCE be pleased to state what percentage of banks loans on 'Self-Employment Scheme' under the new 20-Point Programme, constitute to the gross profits of the concerned banks ?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI JANARDHANA POOJARY) : Under the self-employment scheme, the overall quantum of loans to be provided by the banking system is not meant to be related to the gross profits of the public sector banks. The size of the scheme as earlier conceived was to be about 1% of the total advances made by all the public sector banks during the preceding year. According to the available data, an amount of Rs.401.54 crores was sanctioned by the banks upto 31.3.1984 which constitutes more than 1% of the total advances at the end of March, 1983.

#### Tourism Department's Projects Held up Due to Delay in Getting Clearance

THE MINISTER OF STATE OF THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KHURSHEED ALAM KHAN) : (a) and (b) No projects of Department of Tourism are pending due to delay in receiving clearance from the Ministry of Works & Housing.

#### Private Sector Involved in Promotion of Tourism

(a) whether Government have proposal to involve private sector in the promotion of tourism Industry ;

THE MINISTER OF STATE OF THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KHURSHEED ALAM KHAN) : (a) to (c) Development of tourism infrastructural facilities in the country is a continuous process requiring the combined efforts of the Central, State and the private sector. Private sector has always been involved in the promotion of tourism industry, and no specific steps as such are being taken. In fact the States have to provide inducements to the Private Sector to attract investments.
