## Early Completion of Civil Aerodrome at Simla

## 1918. PROF. NARAIN CHAND PARASHAR:

### SHRI AMAR SINH RATHAWA:

Will the Minister of TOURISM AND CIVIL AVIATION be pleased to state:

- (a) whether Government would ensure the early completion of the construction of the Civil Aerodrome at Simla;
- (b) if so, the exact date by which the aerodrome would be completed and the estimated cost of the project : and
- (c) if not, the reasons therefor and especially because Simla is the only State Capital not linked by air to the Union Capital?

THE MINISTER OF STATE OF THE MINISTRY OF TOURISM AND CIVIL AVIATION (SHRI KHUR-SHEED ALAM KHAN): (a) Construction of an aerodrome at Jabbar-Hatti near Simla was undertaken by the State Government of Himachal Pradesh and approximately 30% of the work of levelling the site was completed. The work was thereafter suspended.

On a request from the State Government, it has been decided that subject to availability of funds and the requisite clearances of the Planning Commission and Ministry of Finance, the Department of Civil Aviation would undertake further development of the aerodrome.

(b) and (c) The estimates for the remaining earth work and provision of a terminal building and other infrastructural facilities are under preparation. The time schedule and the cost of the project will be determined after the estimates and the detailed project report have been finalised.

# Review of the structure and functioning of Regional Rural Banks vis-a-vis Nationalised Banks

In regard to the structure and organisation of these banks a need is felt for some amendments to the Regional Rural Banks Act. Proposals in this regard when concretised will come before the Houses in the form of legislative proposals.
