'Seed Money' by IDBI to State Financial Corporation

(d) whether it has come to the notice of the IDBI that most of the State Financial Corporations could not properly utilise the sanctioned funds; if so, the details thereof; and

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI JANARDHANA POOJARY) :(a) The Industrial Development Bank of India(IDBI) extend assistance through the State Financial Corporations(SFCs) to the small scale sector under the following schemes :

- (1) The Special Capital Scheme under which IDBI contributes to special capital of State Financial Corporation (SFCs) on matching basis with State Governments and the amount is utilised by SFCs to provide seed capital assistance for setting up projects in small sc le, tiny and decentralised sectors.
- (2) Refinance of loans extended by SFCs to small scale sector.
- (3) Composite Loan Scheme under which loans upto Rs. 25,000 for village and cottage industry and artisans provided by the SFCs are refinanced by the IDBI.

(b) Details of assistance extended by the IDBI under the Special Capital Scheme, Refinance and Composite Loan Scheme during the years 1981-82. 1982-83 and 1983-84 are indicated below :

For the financial year 1984-85, IDBI has started making available exclusive sub-limits for providing assistance to artisans and village industry under the Composite Loan Scheme. The IDBI has undertaken a rview of the Special Capital Scheme and Composite Loan Scheme with a view to liberalising these Scheme.
