(b) TFAI is a non-profit making organisation. However, the excess of income over expenditure for the last two years for which final accounts are available is Rs. 14.13 lakhs and Rs. 109 61 lakhs for 1981 82 and 1982-83 respectively. During 1981-82, TFAI organised 5 exhibitions in India and 14 abroad. During 1982-83, it organised 7 exhibitions in India and 38 abroad.

## Imports handled by DGS & D in respect of Aid/Gifts consignments from International Organisations

## Visit of an Indian Delegation to China

1972. SHRIMATI VIDYA CHEN-NUPATI: Will the Minister of COM-MERCE be pleased to state:

(a) whether a delegation led by the Additional Secretary in his Ministry visited China recently;

- (c) the outcome of the visit with particular reference to the possible exports to that country?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND IN THE DEPARTMENT OF SUPPLY (SHRI NIHAR RANJAN LASKAR): (a) to c) Yes, Sir. A five member delegation of the Ministry of Commerce visited China from 20 to 30.6.1984. In the bilateral talks between India & China, views were exchanged on various aspects of tea production and exports. The delegation also visited Chinese tea plantations and tea factories Although no formal agreement has been signed, it was agreed to coordinate policy in order to protect the interests of the tea production countries and to work toward achieving producers' unity with the objective of ensuring stable and remunerative prices for tea. Since the purpose of the delegation was to exchange views between the two countries as major tea producers, matters relating to bilateral trade between the two countries were not discussed.
