## Amendment of Visa Rules

2499. SHRI CHITTA MAHATA: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether Government have recently decided to amend the visa rules for certain categories; and
- , (b) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI P. VENKTASUBBAIAH):

(a) Till the middle of June, 1984, citizens of Commonwealth countries and of Ireland were exempted from obtaining visas for entry into India unless they were coming forther in connection with missionary work. The Passport (Entry into India) Rules, 1950 have been amended on 13th and 16th June. 1984 to cover such citizens of all categories under the visa system. (Citizens of Shri Lanka and Ban\_ladesh have been subject to visa requirm ets all along).

Government have also suspended with effect from 24th June, 1984 until further orders the provision in the Rules for grant of landing permit facility for 90 days to citizens of Norway, Finland, Sweden, Denmark, Yugoslavia, Bulgaria, Iceland and Maldives arriving in India without visas.

Passengers of Mussoorie Express, looted between Jawalapur and Pathri Stations

2501. SHRI JAIPAL SINGH KASHYAP : SHRI CHHOTTEY SINGH YADAV :

Will the Minister of HOME AFFAIRS be pleased to state;

- (a) whether passengers of Mussoorie Express from Delhi to Dehradun were recently looted by armed robbers between Jawalapur and Pathri Stations; and
- (b) if so, details thereof and action taken by Government in the matter?

THE MINSTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRIMATI RAM DULARI SINHA): (a) and (b) According to available information, passengers of a coach of 42 Down Mussoorie Express were looted by 12-15 armed daceits in between Jawlapur and Pathri Stations on the night of 10/11-7-1984 between 11 to 11-30 P.M. One dacoit fired a shot which hit the roof of the begie and the splinters of the roof hit one army sainik. He received a lacerated minor injury near his eye and a minor bruise on the hand. Property worth about Rs, 35,000/belonging to a number of passengers was looted. On the night of 12/13-7-1984 police succeeded in arresting 3 accused persons all residents of village Pathri, Police Station, Jawalapur, District Saharanpur along with 3 country made pistols and 13 live catridges and 3 looted watches were recovered from

their personal search. All the three accused confessed to the dacoity. One more accused resident of Pathri, P.S. Jawalapur, District Saharanpur later on arrested on 15-7-84. He has also confessed to the dacoity.

The following measures have been taken for the safety of the public :-

- 1. All night passenger/Mail/Express trains are escorted by armed police.
- Plain clothes staff has been deputed to watch suspicious persons,
- 3. At way side railway station where there is no Thana or Out-Post, District Police staff have been directed to remain present at Railway Station at train timings to watch the suspicious persons.
- 4. History sheets of active oriminals are being opened.
- Police escort parties have been directed to detrain at every stoppage, where train stops and take a round of the train and watch suspicious persons.

## Revision in rates of royalty

2502, SHRI NITYANANDA MISRA: Will the Minister of STEEL AND MINES be pleased to state :

- (a) Whether the Ministers of Mining and Geology of different States including Orissa have urged upon the Government to revise the rates of royalty of minerals in every two years instead of once in every four years;
- (b) whether the revisions in the royalty rates on iron ore and manganese ore have become due from 12 June, 1982 and 1st January, 1983 respectively;
- (c) if so, why the royalty rates of fron ore and manganese have not been evised so far; and

(d) the steps taken to revise the royalty rates of minerals at a early date?

THE MINISTER OF STATE OF THE MINISTRY OF STEEL AND MINES (SHRI N, K, P. SALVE) : (a) Yes. Sir.

- (b) Section 9(3) empowers Central Government to enhance or reduce the rate of royalty of minerals. However, the rate of royalty cannot be enhanced more than once during a period of four years. The last revision in the royalty rates on iron ore and manganese, ore was made on 12,6, 1978 1.1.1979 and therefore. minimum period of four years expired on 12.6,1982 and 1.1.1983 respectively.
- (c) and (d) The proposal for revision of the royalty rates on these minerals is already under consideration.
