## Programme for Developing a Pool of Marine Scientists

4128. SHRI K. MALLANNA: Will the PRIME MINISTER be pleased to state:

- (a) whether in order to create a self-reliance technological base for tapping the nation's vast ocean resources, Department of Ocean Development have initiated an ambitious programme for developing a pool of marine scientists; and
- (b) if so, the steps taken by Government in this regard so far as the question of initiation of the followships and asociateships along with the subjects are concerned?

THE MINISTER OF STATE IN THE DEPARTMENTS OF SCIENCE AND TECHNOLOGY, ATOMIC ENERGY, SPACE, ELECTRONICS AND OCEAN DEVELOPMENT SHRI SHIVRAJ V. PATIL): (a) Yes, Sir.

(b) The Department of Ocean Development has initiated a number of followships and research associateships in different centres, universities and central organisations which are involved in

marine-oriented work. Nearly 25 fellows are already in position in the disciplines of marine biology, marine chemistry, marine geology, marine geophysics, marine instrumentation etc. The fellowships and research associateships are awarded to about 125 persons per year. The fellowship scheme has certain disdinct advantages as no major institutional set-up is required for this purpose. The existing centres of excellence can be used to take up new fellowships in specialised branches of marine science and technology.
