Families brought above poverty line during last three years

SETHI): The estimates made in this regard relate to persons, and not families, The Statewise estimates of people below the poverty line are based on the periodic consumer expenditure surveys conducted by the National Sample Survey Organisation. The latest survey for which data are available is for the year 1977-78, The next survey was conducted in 1983. After the availability of the results of this survey, the statewise estimates of persons below the poverty line would be worked out. The estimates for 1977-78 have been indicated in the Sixth Five Year Plan The Planning Commission Document. has not fixed any statewise targets of people crossing the poverty line,
