Gwalior, Jabalpur and other tourist centres through Khadi and Village Industries Commission?

THE MINISTER OF COMMERCE AND INDUSTRY AND OF THE DE-OF **SUPPLY** PARTMENT VISHWANATH PRATAP SINGH): (a) The Khadi and Village Industries Commission (KVIC) an autonomous organisation set up under KVIC Act, 1956, has been entrusted with the task of development of khadi and village industries throughout the country. At present, the Commission has been planning, organising and implementing programmes for development of khadi (cotton, woollen and silk) and 25 village industries specified in the schedule to KVIC Act. In the state of Madhya Pradesh, the Commission's programmes are implemented through the State KVI Board, 29 registered institutions and 1477 cooperatives. addition to this normal programme, KVIC is also proposing to implement the Integrated Rural Development Programme in selected blocks in the State with the assistance of DRDAS, for which purpose, 48 blocks in 20 districts have been selected.

(b) In Madhya Pradesh there are 108 Khadi Gramodyog Bhandars. There are Khadi Gramodyog Bhandars at Indore and Gwalior also run by the institutions certified by the KVIC. At present there is no proposal to open departmental Bhavans at Gwalior, Jabalpur and Indore. A Khadi Gramodyog Bhawan set up by KVIC has been functioning at Bhopal since 1964 and a proposal to open a branch of it at BHEL Colony in Bhopal is under consideration.
