One Ayurvedic and one Homoeopathic Unit is functioning in the newly constructed CGHS dispensary building at Harinagar. A part of the premises is also being used as CGHS Store Depot temporarily.

Allocation of Development Fund to Mithila and other Universities

4525. SHRI BHOGENDRA JHA : Will the Minister of EDUCATION AND CULTURE be pleased to state :

(a) the total amount given as development fund to the Mithila and other Universities during the last five years ; and

(b) the causes of Mithila University and K.S. Sanskrit University getting the step-motherly treatment ?

THE MINISTER OF STATE OF THE MINISTRIES OF EDUCATION AND CULTURE AND SOCIAL WELFARE (SHRIMATI SHEILA KAUL) : (a) During the Sixth Plan (1980-85), for providing general development assistance, universities were classified into 3 categories each with an allocation of Rs. 1 crore, Rs. 75 lakhs and Rs. 50 lakhs respectively. The names of universities in these 3 categories are given in the attached statement. The L.N. Mithila and K.S.D. Sanskrit universities are in the categories of universities with allocations of Rs. 75 and Rs. 50 lakhs respectively.

(b) The allocation to each university is determined on the basis of its state of development, the type and nature of programmes offered by it, the student enrolment and faculty strength, the progress of development schemes already implemented, and other relevant factors. The question of discrimination against any individual university in this matter does not arise.
