(b) if so, whether any simplification in them have been devised so that Income Tax Officers can pay more attention to big assessees and tax evaders than on assessees with income of loss than Rs\_50,000 per year; and

(c) if so, the details thereof?

THE MINISTER OF STATE IN THE MINISTRY OF FINANCE (SHRIS M. KRISHNA): (a) Yes, Sir.

(b) and (c) With a view to speed up the disposal of income tax assessments with the manpower available, instructions have recently been issued that salary cases with returned income up to Rs. 50,000/- and nonsalary cases with returned income up to Rs. 25,000/-, subject to certain exceptions, - be completed without any checking of any sort.
