Will the Minister of ENERGY be pleased to state :

- (a) whether Central Government undertook investigation for exploration of oil and natural gas in the river basins of Krishna, Godavari, and Cauvery rivers;
- (b) if so, the quantity of oil and natural gas estimated to be available in these river basins;
- (c) the steps taken to help these resources;
- (d) whether American aid is sought in such exploration and tapping of oil and natural gas in the Krishna river basin; a nd
 - (e) if so, the particular thereof?

THE MINISTER OF STATE IN THE DEPARTMENT OF PETROLEUM IN THE MINISTRY OF ENERGY (SHRI GARGI SHANKAR MISHRA): (a) to (c) As a result of extensive geological & seismic surveys carried out in the Krishna, Godavari and Cauvery basins, a large number of structures have been identified. Drilling has been done on a number of structures and so far about thirty million tonnes of hydrocarbon reserves have been estabilished. Further surveys and drilling are continiing in these basins.
