THE DEPUTY MINISTER IN THE MINISTRY OF COMMUNICATIONS (SHRI VIJAY N. PATIL): (a) No. Sir.

(b) and (c) It is not proposed to provide Digital Electronic Exchanges in towns other than telephone districts, in the 6th Plan due to limited availability of electronic swithing equipments. When adequate indegeneous production of electronic switching equipment becomes available in the country in the 7th Plan, provision of such exchanges in District towns might be considered.

Setting up of Non-Conventional Energy Units in Rural Areas

1362. SHRI BALASAHEB VIKHE PATIL: Will the Minister of ENERGY be pleased to state:

- (a) whether Government have sponsored a programme to set up non-conventional energy units in rural areas to help the village artisans, and also for irrigation;
- (b) if so, how many such units are likely to be set up in Ahmadnagar (Maharashtra);
- (c) whether any scheme has been drawn up in this connection, particularly energy produced through bio-gas, wind mills etc
 - (d) if so, the details thereof; and
 - (e) if not, when this will be done?

THE MINISTER OF ENERGY (SHRIP. SHIV SHANKAR): (a) Yes, Sir.

(b) In Ahmadnagar district, five windpumps and two solar photovoltaic pumps
for lifting water have been installed; further,
a solar water heating system and an institutional biogas plant are being established.
Family type biogas plants and improved
chullahs are allo being set up. Discussion
are in progress with the State Government
regarding installation of additional nonconventional energy units in Maharashtra,
including Ahmadnagar district.

- (c) and (d) Schemes have been drawn up for large-scale installation of biogas plants, improved chullahs, solar cookers and other solar thermal energy devices. These schemes include provision of subsidies and other incentives, training, and post installation maintenance. Demonstration and field trial programmes are also underway for windpumps; solar photovoltaic systems for pumping, lighting, television and radio; community/institubiogas tional plants; and energy plantations.
 - (e) Does not arise.
