- 2 According to an amendment to the Iron & Steel (Control) Order notified on 29-3 71, use of iron of steel otherwise than for the purposes mentioned by the person in his application is prohibited. Therefore if a person obtaining steel uses it for purposes other than what is indicated by him in his application for that steel he will now be liable to prosecution and conviction under Section 7 of the Essential Commodities Act
- 3. Whenever any case comes to the notice of Government, suitable action will
