(ग) 1 फरवरी, 1967 को कूल 204 ग्रनिधकत कालोनियां थीं। इनमें से 157 को पहले ही नियमित कर दिया गया है। शेष कालोनियों को जो नाम-कनफरिंग क्षेत्र में नही हैं. (उनको छोडकर जिनमें कछ या बिलकल संरचनाएं नहीं हैं) नियमित करने की कार्य-वाही दिल्ली तगर निगम तथा दिल्ली विकास प्राधिकरण द्वारा की जा रही है।

Refinery in Uttar Pradesh

3911. SHRI K. C. PANDEY · Will the Minister of PETROLEUM. AND CHEMICALS be pleased to state:

- (a) whether any Refinery is to be set up in Uttar Pradesh ·
- (b) if so, the broad features of the proposal: and
- (c) the time by which it is likely to be completed?

THE MINISTER OF PETROLEUM AND CHEMICALS (SHRI P. C. SETHI): (a) to (c). It is proposed to set up a new oil refinery in North-West Region. The feasibility report prepared by IOC for the refinery is being examined.

Pollution in Kishangani and Indraprastha Estate in Delhi

3912. SHRI P. K. DEO: Will the Minister of HEALTH AND FAMILY PLANNING be pleased to state:

- (a) whether Government are aware of the exhibits displayed by the Meteorological Department at its recent exhibition to mark the 11th World Meteorological Day, depicting the state of pollution in the capital particularly in Kishanganj and that according to the Department. Indraprastha Estate alone is responsible for spreading 80 tonnes of pollution per square mile a month; and
- (b) if so, the steps proposed to be taken or taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (SHRI D. P. CHATTOPA-DHYAYA): (a) Yes. The Central Public Health Engineering Research Institute. Nagpur, had put up a chart in this exhibition. The chart displayed the results of a short-term study on parameters like Sulphur dioxide. Nitric oxide. Hydrogen sulphide. Ozone and suspended dust at five sampling stations undertaken by the Central Public Health Engineering Research Institute in Delhi. Sulphur dioxide was comparatively high in Kishangani area. According to the study air pollution in Kishangani is due to emissions from the railway locomotive.

Written Answers

The Central Public Health Engineering Research Institute has no sampling station in the Indraprastha Estate and no survey has so far been conducted on the air pollution levels at the Indraprastha Estate. The figures calculated from the capacity of the Indraprastha Power Station indicate that the emissions should be of the order of 60 tonnes of Sulphur-dioxide and 45 tonnes of soot per day from this Station.

(b) Government is fully aware of the problem of pollution in the big cities of the country and proposes to bring forth legislation on the subject.

Family Planning Centres in Kerala State

3913. SHRI PHOOL CHAND VERMA: Will the Minister of HEALTH FAMILY PLANNING be pleased to:

- (a) the number of Family Planning Centres functioning in the State of Kerala; and
- (b) the number of new Family Planning Centres Government are going to start in the current year?

THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY PLANNING (SHRI D. P. CHATTOPA-DHYAYA): (a) 29 Urban Family Welfare Planning Centres and 163 Rural Family Welfare Planning Centres along with 1591 Sub-centres are functioning in Kerala.

(b) The State Government propose to establish 120 additional sub-centres under the Family Planning Programme during 1971-72.
