## Erosion and Damage in Malda by Floods

(d) if so, the reaction of Government in this regard ?

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND POWER (SHRI B. N. KUREEL): (a) and (b): The Government of West Bengal have reported that there have been no serious flood in the Malda District so far this year. However, three yillages had been eroded by the river Kalindi in Ratua Police Station area of Malda district. The State Government have sanctioned Rs. 50,000/- for distribution as grants towards cost of shifting of houses of the affected people.

(c) There has been no damage to the Farakka Barrage Project due to the recent floods ?

(d) Does not arise.
