- (c) if so, the number of posts which have been upgraded in each Zone of the Railways separately, Division-wise; and
- (d) the grades in which the posts reserred to in part (c) above have been upgraded?

THE MINISTER OF RAILWAYS (SHRI HANUMANTHAIYA): (a) Yes, the recommendation has accepted in principle.

- (b) The Zonal Railways have been advised that prima facie there is a case for bringing the supervisory structure of the Commercial Department in parity with the Operating Department and to examine the phasing of the implementation of this recommendation and submit their proposals as to how best the recommendation could be implemented identifying the posts to be upgraded, in what grades they should be placed and the justification therefor.
- (c) and (d) The matter is still under examination.

## Issue of publications in Hindi by Western Railway

4075. SHRI B. N. BHARGAVA: Will the Minister of RAILWAYS be pleased to state:

- (a) the reasons why the Western Railway Administration is not publishing the notifications in Gazette in Hindi and English and the Traffic supplement in Hindi-English bilingual form, according to the provisions of the Official Languages Act; and
- (b) the measures contemplated by the Railway Board for implementation of the instructions issued in this regard?

THE MINISTER OF RAILWAYS (SHRI HANUMANTHAIYA): (a) and (b). At present all important notifications are published in Hindi and in English in the Western Railway Gazette. The Western Railway is however being asked to publish their Gazettes and Traffic Supplement in Hindi also in addition to English.

## Use of Hindi in Western Railway Headquarters Office, Bombay

4076. SHRI B. N. BHARGAVA: Will the Minister of RAILWAYS be pleased to state:

- (a) the number of letters addressed in Hindi during the last one year by the Western Railway Headquarters Office Bombay to the (i) State Government who have accepted Hindi for correspondence; (ii) Railway Board; and (iii) other Central Ministries; and
- (b) if not, the reasons therefor and arrangements proposed to be made to implement the provisions of the Official Languages Act?
