Demand by Railway Employees for increase in Interim Relief

7429. SHRI K. MALLANNA : SHRI RAMSHEKHAR PRASAD SINGH : SHRI S. M. BANERJEE :

Will the Minister of RAILWAYS be pleased to state :

(a) whether Railways employees had held a demonstration in New Delhi on the 5th July, 1971 in connection with their demand for the grant of additional Interim Relief;

(b) if so, whether the demonstrators were addressed by the Railway Minister;

(c) whether his Ministry has taken up this issue with the Finance Ministry; and

(d) if so, the amount of the Interim Relief that is proposed to be given to Railway employees ?

THE MINISTER OF RAILWAYS (SHRI HANUMANTHAIYA) : (a) and (b). Yes, Sir.

A deputation of National Federation of Indian Railwaymen, which held the demonstration, presented to the Prime Minister on the same day, a memorandum demanding grant of interm relief of Rs. 78.75 per employee per month.
