IN THE THE DEPUTY MINISTER AND OF IRRIGATION MINISTRY POWER (SHRI B. N. KUREEL): (a) and (b). The Government of West Bengal have reported that there has been some change in the course of the Jaldhaka river and as a result, it is now flowing close to the Mathahad also bhanga town. Severe erosion taken place near the town. The State Government have taken measures to check the erosion and the situation is now reported to be under control.

Rest Giver and Leave Reserve Staff for S & T Branch, Jaipor Division (Western Railway) and other Places on Indian Railways

7506. SHRI B. P. MAURYA : SHRI DHAN SHAH PRADHAN:

Will the Minisser of RAILWAYS be pleased to state :

(a) whether in Jaipur Division of Indian Railways, no post of Rest Giver and Leave Reserve staff for any cadres of Signal and Telecommunication branch is existing with the result that staff is deprived of the benefit of suspense free weekly rest and timely leave;

(b) whether there is also no duty roster of staff of Signal Inspector, Delhi Avoiding Line, Hazrat Nizamuddin and there is no arrangement of Weekly Rest and timely leave for this staff; and

(c) if so, the action taken to remove this grievance on all the places on Indian Railways ?

THE MINISTER OF RAILWAYS (SHRI HANUMANTHAIYA): (a) Leave reserve for Signal/Telecommunication Inspectors in all grades is provided in the category of Assistant Signal/Telecommunication Inspectors. Leave reserve posts for the categories of Electrical/Mechanical Signal maintainers and Telecommunication Maintainers are provided in the category of Helpers. Periodic rest is also granted through separate Rest Givers wherever necessary.

(b) The posts under Signal Inspector Delhi Avoiding Line Hazrat Nizamuddin have recently been sanctioned and non-cyclic duty rosters for them have since been provided. The weekly rest has been catered for within the roster.

(c) Does not arise.

Posts of Sub-Editors lying vacant in Ministry of Law and Justice

7507. SHRI G. Y. KRISHNAN : Will the Minister of LAW AND JUSTICE be pleased to state :

(a) whether there arc some posts of Sub-Editors lying vacant since long and they are not being filled up because these are reserved for scheduled Castes/Tribes in his Ministry;

(b) if so, whether there are some percentages fixed for Scheduled Caste and Scheduled Tribe candidates in these posts; and

(c) whether the High Court judgments are being got translated on Overtime basis?
