See No. LT-506/71], that all the existing costs of Lower Division Clerks and Upper Division Clerks with a special pay of Rs. 20 or Rs. 30 for stenographic work will be converted into posts of stenographers (a) in the scale of Rs. 130-5-160-8-200-EB-8-256-EB-8-280 to be called Grade III of the Central Secretariat Stenographers' Service in Ministries/Offices participating in the Central Secretariat Stenographers' Service and in other Ministries/Departments of the Government of India, and (b) in the scale of Rs. 130-5-160-8-200-EB-8-256-EB-8-260-10-300 (the same as applicable to Upper Division Clerks) in subordinate offices and other offices of the Government of India.
