#### SHRI BIREN DUTTA: 2890. SHRI M. M. JOSEPH: SHRI DEVINDER SINGH GARCHA:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether any scheme to form Coordinating Committee for the development of Tripura, Manipur and Meghalaya areas has been accepted by the Government of India:
- (b) if so, the composition and terms of reference of the Committee;
- (c) wheter it will come into existence before the Statehood Bill for Tripura and Manipur is introduced; and
  - (d) if so, the reason thereof?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI K. C. PANT): (a) to (d). In the context of granting Statehood to Manipur, Tripura and Meghalaya, Government are considering the question of having a coordinating agency for the entire North-Eastern region. The details are being worked out. At this stage it is not possible to indicate the precise nature of the legislation for this purpose.

- 2892. SHRI J. M. GOWDER: Will the Minister of FOREIGN TRADE be pleased to state:
- (a) the amount of Cess on Tea collected from the Nilgiri District in Tamil Nadu in the past three years;
- (b) the manner in which the collected has been utilised;
- (c) whether any procedure has drawn for the utilisation of the proceeds of the cess in the areas of collections and for the benefit of the industry in general and

for the welfare of the labour in particular; and

(d) if not, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF FOREIGN TRADE (SHRI A. C. GEORGE): (a) The amount of cess collected from the Nilgiri district in Tamil Nadu is given below:

1968-69	Rs. 12,24,566
1969-70	Rs. 13,72,713
1970-71	Rs. 13,84,752

- (b) Cess on Tea is collected by Central Excise Department and proceeds thereof are credited to consolidated Fund of India after deducting collection charges at the rate of half per cent. Thereafter Central Government releases such sums of money as it thinks fit with a view to enabling Tea Board to meet expenses incurted by them for carrying out functions enumerated in the Tea Act.
- (c) and (d). In keeping with functions of the Board as enumerated in the Tea Act procedures have been laid down in the Tea Rules 1954 for submission of Budget Estimates under various stipulated heads of expenditure like tea development, promotion of tea in India and abroad, research, labour welfare etc. Funds are allocated on the basis of the overall needs of the Tea Board in relation to priority of different aspects of tea industry requiring immediate attention including labour welfare measures not covered by Plantation Labour Act.

# New Building for P. and T. Head Office at Irinijalakkuda (Kerala)

- 2893. SHRI M. K. KRISHNAN: Will the Minister of COMMUNICATIONS be pleased to state:
- (a) whether Government are aware of the acute lack of space in the present Posts and Telegraphs Head Office Irinijalakkuda, Kerala;
- (b) whether a plan for construction of new building was finalised by the Central Architect years back; and
- (c) the reasons for delay in the construction of new building?

THE MINISTER OF COMMUNI-CATIONS (SHRI H. N. BAHUGUNA): (a) Yes. A portion of the post office has therefore been shifted to a nearby building which was taken on rent in 1969 in an attempt to solve this problem. The present shortage is about 1100 sq ft.

- (b) Only a rough layout plan showing the proposed extension of the building on the site has beεn received from the Architect in January, 1970 by the Postmaster General, Trivandrum. Detailed plans and preliminary drawings are still under preparation.
- (c) The delay is due to several projects having to be attended to at the same time. This project has, however, been given a higher priority and is being expedited.
