Pakistani's threats of breaking off Diplomatic Relations with India

However the Pakistan Government had wrongly alleged that India was not interested in the diplomatic missions in the two countries operating under normal conditions, Actually Pakistan had unilaterally placed restrictions on the exit of members of the Indian Missions in Pakistan to which India had to take reciprocal action.

Bangla Desh Refugees sent to Dande karanya

THE MINISTER OF LABOUR AND REHABILITATION (SHRI R. K. KHADIL-KAR): (a) No, Sir.

- (c) The policy of the Government of India is that the refugees should be repatriated to Bangla Desh as soon as conditions are favourable there. It has been accordingly considered desirable to lodge these refugees in Camps located close to the border or in the interior of West Bengal or in other neighbouring States where sufficient land is available for putting up Camps or temporary structures.
