In handling Hindi telegrams.

- (b) It is not a fact that most people send telegrams in Hindi, nor is there any accumulation of Hindi telegrams.
 - (c) The question does not arise.

Construction of Head Post Office Building in Bihar

- 406. KUMARI KAMALA KUMARI: Will the Minister of COMMUNICATIONS be pleased to state
- (a) whether his attention has been deawn to the news appearing in the Bihar newspaper namely Saptahik Haldhar dated the 29th July 1971 wherein a description of Head Post Office has been given;
- (b) whether the Head Post Office is housed in a very costly private rented building because the new building meant for it has not been constructed even after more than nine years: and
- (c) whether the old Government building where the Post Office was housed has been demolished and the time by which the new Post Office building is likely to be built?

THE MINISTER OF COMMUNICA-TIONS (SHRI H.N. BAHUGUNA): (a) It is presumed that the Member is referring to Deltonganj Head Post office which is functioning in a rented building since 17-2-63 at a rent of Rs. 950/- per month which is considered reasonable. The old departmental building whese Daltonganj Head Post office was functioning earlier to 1963 was demolished to make room for the construction of a new building. The work was delayed due to frequent changes in the plans. However, it has now been started and is likely to be completed by Sept. 1972.

Supply of Advertisement Materials to Small Newspapers

THE DEPUTY MINISTER IN THE MINISTRY OF INFORMATION AND BROADCASTING (SHRI DHARAM BIR SINHA): (a) and (b). Advertising Agencies are not controlled by Government. Government do not, therefore, maintain any list of such agencies.

Advertising agencies which seek accreditation with Government are granted such accreditation by the Directorate of Advertising and Visual Publicity provided they accopt inter alia Government's policy of encouraging small and medium newspapers.

(c) A list of such accredited advertising agencies located in Delhi is placed on the Table of the House. [placed in Library. See No. L.T-100/71]
