Pak Saboteurs in Assam and Meghalaya

- 526 SHRI RAMSHEKHAR PRASAD SINGH: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether the Pakis am saboteurs who have infiltrated with the Bangla Desh refugees into Assam and Meghalaya are reported to have been directed to contact some known men among the Nagas and Mizo rebels to carry out their assignments;
- (b) whether these saboteurs have been very active in these States; and
- (c) If so, what action or steps Government have taken to arrest them?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F H. MOHSIN): (a) The links between

Pakistan and the Naga and Mizo rebels are well known, and utmost vigilance is maintained in regard to possibilities of contacts between Naga and Mizo malcontents and Pakistani saboteurs.

- (b) There have been a number of incidents of sabotage and attempted sabotage in the border districts of Assam and Meghalaya.
- (c) According to information received from the Government of Assam, 67 persons have been arrested in Assam and Meghalaya.

Closure of Industries in Assam due to Non-Availability of Raw Materials

- 527. SHRI DINESH CHANDER GOSWAMI: Will the Minister of INDUS-TRIAL DEVELOPMENT be pleased to state:
- (a) whether Government are aware that many industrial units in the Eastern region, particularly in Assam are facing closure due to non-availability of raw materials;
- (b) if so, the steps Government propose to take to make raw materials available to these units; and
- (c) if not, steps are contemplated in the matter, the reasons therefor?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOP-MENT (SHRI SIDDHESHWAR PRASAD):

(a) While the Government is aware of the general shortage of certain raw materials, we have no specific information about closure of Industrial Units in Assam on this account.

(b) and (c). There is a general shortage of certain industrial raw materials like steel including stainless steel, caustic soda, soda ash and calcium carbide etc. which is affecting Industrial production in certain industries.

With a vie v to make available the required raw material to the industrial units, the supply position is reviewed periodically and necessary correctives are applied. A number of steps have since been taken to

increase the production of items which are currently in short supply and are likely to be in short supply for some time to come.

The import policy concerning the import of industrial raw materials is also being reviewed from time to time by the Standing Internal Departmental Committee to meet the short-term scarcity conditions. The import policy of 1971-72 contains special provisions for import of items which are in world short-supply. The industries which are affected due to short supply of rawmaterials arising from the world shortage are being permitted to apply for import of raw materials for over a period of six months at a time.

The import policy also provides for review of entitlements of Actual Users. Cases of Actual Users, in which it is established that the operation of existing import policy has caused undue hardship and is likely to affect industrial production, are considered for imports by the Sub-Committee under the C.C.I and E.

Industries in Meghalava

- 528 SHRI DINESH CHANDER GOSWAMI: Will the Minister of INDUS-TRIAL DEVELOPMENT be pleased to state:
- (a) whether Government are aware that in the entire South bank of river Brahmputra in the District of Kamrup and the State of Meghalaya there is no industry in spite of rich mineral potentials;
- (b) if so, the steps Government propose to take to develop the potential industries of this region; and
- (c) if no steps are being contemplated, the reasons therefor ?

THE MINISTER OF STATE IN THE MINISTRY OF INDUSTRIAL DEVELOP-MINT (SHRI GHANSHYAM (a) to (c). For an overall assessment and fuller utilisation of the natural resources that are available in the North-Eastern region, including Assam and Megalaya, three working groups viz. (i) Agro-based industries, (ii) Forest based industries and (iii) Coal and Natural Gas or generally for mineral based industries were set up under the auspices of the Standing Committee of the Eastern Zonal Council, to conduct detailed studies on the integrated industrial potential of the region. On the basis of these studies, it is proposed to draw up a coordinated plan for the integrated industrial development of the region. The reports of the Working Group are currently under the consideration of the Standing Committee of the Eastern Zonal Council. It may be added that provision for a cinnamon oil project and provision for investigation, survey, preparation of feasibility reports etc., have been made in Meghalaya's 4th Plan programme. Besides, the Ministry of Industrial Development had also recently sent a study team to explore possibilities of setting up industries in Meghalaya. It is hoped that as a result of these measures some industries will be set up in Meghalaya and the Kamrup region.

Closure of Newspapers in Assam due to Non-Availability of Newsprint

- 529. SHRI DINESH CHANDER GOSWAMI: Will the Minister of INDUS-TRIAL DEVELOPMENT be pleased to state :
- (a) whether Government are aware that many newspapers in Assam are facing closure due to non-availability of newsprint; and
- (b) if so, the steps taken by Government to make newsprints available to the newspaper industry in Assam ?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRIAL DEVELOP-MENT (SHRI SIDHESHWAR PRASAD): (a) No. Sir.
