(b) However, the revision of Royalty on Iron Ore is under Government's consideration. An increase in respect of coal had been also allowed earlier in the year, in changing the ad valorem rate into a per-Tonne basis. A general Mineral Development cess has not been found acceptable.

Lock-Out in Bharat Earthmovers Limited, Bangalore

- (a) whether the Bharat Earthmovers Limited, Bangalore have declared lock-out recently;
- (b) the number of workers affected by this lock-out and the reasons therefor; and
- (c) whether the lock-out has been withdrawn?

THE MINISTER OF LABOUR AND REHABILITATION (SHRI R. K. KHA-DILKAR): (a) Yes, on September, 21, 1971.

- (b) The number of workers affected by the lock-out in the Bangalore unit is reporten to be about 4,000. The reason for the lockout as pointed out by the management was unjustified strike and violent activities by the workers.
- (c) The lockout was lifted from the third shift of October 1, 1971 following an amicable settlement.
