Policy Regarding Registration of Re-rolling Mills of Iron

SHRI NARENDRA SINGH : Will the Minister of STEEL AND MINES be pleased to state:

- (a) the policy laid down and followed in respect of registration of re-rolling mills of iron which have been set up after the report of the Technical Committee; and
- (b) the names of the re-rolling mills which have been registered subsequent to the report of the Technical Committee either for only statistical purposes or for allotting guta of billets?

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI SHAHNAWAZ KHAN): (a) Steel re-rolling mills are sanctioned industrial licences or registered in accordance with the policy of industrial licences in force. Currently, units whose value of machinery and equipment is less than Rs. 7.5 lakhs will be registered as Small Scale Units with the Directorates of Industries. Thoss whose assets are less than Rs. I crore and who fulfil certain other condititions will be registered by the Iron and Steel Controller for statistical purposes. The remaining units will have to apply for industrial licence.

This record of capacity for purposes of industrial licensing does not, however, automatically entitle units for registration as billet re-rollers. New units are not generally registered as billet re-rollers after the report of Technical Committee in line with their recommendations.
