THE MINISTER OF RAILWAYS (SHRI K. HANUMANTHAIYA) : (a) Yes

(b) The Planning Commission, to whom a reference was made, suggested that the provision of a B G, line from Dehri-on-Sone to Amyhore/Banjari may be kept in abeyance till the question of Sindri expansion is settled by the Committee appointed for the purpose. Further advice from the Planning Commission is awaited.

Statement

UNIDO's Industrial Promotion Service (IPS) make use of Industrial and trade fairs as good contact points to promote potential business transactions for the benefit of developing countries. It provides participants of developing countries with an opportunity to meet their counter-parts from industrialised countries who generally are in a position to supply know-how equipments and/or commercial cooperation. Industry Days are organised by the I. P. S to give the potential consumers and suppliers the chance to make formal or informal presentations and to discuss their specific needs and problems. Private meetings are also arranged on request so that the parties concerned can explore possibilities involving joint ventures ; advisory services or managerial assistance.

UNIDO propose to send a team of experts at their cost to run the Industrial Promotion survec in the Fair.

Appointment of Chief Justices of High Courts

6344. SHRI SOMNATH CHATTERJEE : Will the Minister of LAW AND JUSTICE be pleased to state :

(a) the criteria for appointment of Chief Justice of a High Court by transfer of a Judge from another High Court ; and

(b) whether the Chief Justice of India is consulted in cases of such transfers and appointments?

THE MINISTER OF LAW AND JUS-TICE AND PETROLEUM AND CHEMI-CALS (SHRI H. R. GOKHALE): (a) and (b). The criteria followed for appointment of Chief Justice by transfer from another High Court are merit and suitability as revealed by qualifications and experience and the record of performance as a Judge of the High Court. The Chief Justice of India is invariably consulted before a Judge is transferred from one High Court to another.
