#### Gypsum Deposits in Jammu and Kashmir

THE MINISTER OF STATE IN THE MINISTRY OF STEEL AND MINES (SHRI SHAHNAWAZ KHAN) · (a) As a result of investigations carried out by the Geological Survey of India, gypsum deposits have been located in two major belts in Jammu and Kashmir, viz. Ramban-Batoli-Assar belt in Doda district, Jammu and Ijara, Islamabad, Dhanni Saiyadan belt in Kashmir. Gypsum is also found in Puga valley, m Ladakh

(b) The estimated potential of gypsum reserves are of the order of 21:59 million tonnes upto 30.48 meters depth extension in Jammu Province and 57 52 million tonnes upto 30 48 meters depth extension in Kashmir Province Gypsum reserves of Ladakh have not so far been assessed

(c) The Gypsum deposits in Kashmir region are picsently being used by Wuyan Cement factory in Srinagar The State Government are also having a proposal to mine gypsum from lammu area for manufacturing sulphuric acid and to supply 1 000 tonnes of gypsum to Department of Agriculture, Jammu & Kashmii to reduce alkalinity of the soil, and to small scale units manufacturing crayons, plaster of Paris
