## Permanent Building for Bhadrak Post Office

1093. SHRI ARJUN SETHI: Will the Minister of COMMUNICATIONS be pleased to state the steps taken to construct a permanent and extensive building to provide Bhadrak Post Office, District Balasore, Orissa with minimum requirements of functioning efficiently?

THE MINISTER OF COMMUNICA-TIONS (SHRI H. N. BAHUGUNA): It has been decided by the Government to construct a suitable extension to the existing Head Post Office building at Bhadrak to provide the required accommodation. Administrative approval and expenditure sanction for the project have since been issued.

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) and (b). Facts are being ascertained from the State Governments concerned.

## Statehood for Delhi

1096. SHRI M. M. JOSEPH: Will the Minister of HOME AFFAIRS be pleased to state :

- (a) whether Government have considered any proposal for granting the Statehood to Delhi;
- (b) if so, the sailent features thereof; and
  - (c) the decision taken thereon?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) Yes.

(b) and (c). From time to time it has been suggested to the Government that the Union Territory of Delhi should be made a State. Delhi had been specially carved out from the adjoining provinces into a separate administrative unit under the direct Central administration to serve as the capital of the country. Government consider that the demand for Statehood is not compatible with the present position.
