Earlier, in the eighties, the Indian Institute of Mass Communication (I.I.M.C.) conducted audience reaction surveys and study of film censorship and submitted four reports. However, in accordance with the recommendations of the Estimates Committee (10th Lok Sabha) and the Standing Committee on Communications, it was decided in April 1996 to entrust a study on "Sex and violence in films and its impact on society" to the I.I.M.C. The terms of reference of the study were determined in consultation with the Central Board of Film Certification and expenditure sanction of Government for the study was issued in August 1996 The I.I.M.C. will complete the study within one year from the date of commencement.
