(b) if so, the reasons therefor; and

(c) whether it will affect the interests of the candidates from backward areas of Rajasthan ?

(b) The decision was taken in response to demands for locating Railway Service Commissions in more central places and in pursuance of my statement in the House ou 15.6. 1971 while winding up the discussions on demands for grants (Railways) 1971-72.

Introduction of a Night Train from Dharamnagar and Silchar to Lumding

3946. SHRIMATI JYOTSNA CHAN-DA: Will the Minister of RAILWAYS be pleased to refer to the reply given to Unstarred Question No. 1298 on the 28th March, 1972 and state :

(a) whether the train No. 203/204 does not run through Badarpur-Lumding during night;

(b) whether Government propose to introduce extra trains from Dharmanagar and Silchar to Lumding and Gauhati during night; and

(c) if so, an outline of the proposal?

THE MINISTER OF RAILWAYS (SHRI K. HANUMANTHAIYA): (a) No, 203 Up/204 Dn. Passenger trains do run during night on Lunding-Badarpur section. No. 203 leaves Badarpur at 19:00 hrs. and reaches Lunding at 5:00 hrs. No. 204 leaves Lunding at 18:45 hrs. and arrives Badarpur at 5:05 hrs, thereby effecting
